The general contractor agrees to make no payment to subcontractor until it has received a preliminary lien notice release with respect to the particular payment. An officer, or manager at Allied Plumbing & Fire Supply must sign the preliminary lien notice release it receives from Allied Plumbing & Fire Supply as follows:

- 1.) One check shall be a joint check payable to Allied Plumbing & Fire Supply and subcontractor for the amount specified in Allied Plumbing & Fire Supply's preliminary lien notice release.
- 2.) The second check should be a single party check payable to the subcontractor for work performed before the date of Allied Plumbing & Fire Supply's preliminary lien notice release.

The parties understand and agree that the subcontractor is an independent contractor and is not the agent, partner of joint venture of General Contractor of Allied Plumbing & Fire Supply. In the even of any dispute relating to this agreement, the successful party shall be entitle to reasonable attorney's fees. The subcontractor hereby appoints Allied Plumbing & Fire Supply as its *Attorney in Fact* to sign its endorsement to the back of any jointly payable checks received from the General Contractor.

This agreement shall be binding upon and insure to the benefits of the parties hereto and their respective heirs, executors, administrators, legal representa-tives, successors, and their respective heirs, executors, administrators, legal representatives, successors, and assigns where permitted by this agreement. Allied Plumbing & Fire Supply reserves all rights and remedies allowable by law to obtain payments due if said payment is not received above. Agreed and Accepted:
